Chairwoman Deb Goebel called the meeting to order.

Public Comment:

An inquiry about using the front of the fire-hall for a community book club gathering space, at no charge, was presented to council. Council agreed that it could be used for this purpose at no charge.

Biederstedt made a motion to enter executive session for personnel reasons, at 7:02 p.m., seconded by Struckman. All voted in favor, motion passed. Struckman made a motion to end executive session at 7:29 p.m., seconded by Miller. All voted in favor, motion passed.
