The Secretary's Award for Drinking Water Excellence was presented to the Town of Hayti, and to Corwin Namken, Maintenance Supervisor.

First reading of Ordinance #323 – Amend Ord. #103 & #312-A Prescribing Rates and Regulations for the Operation of the Waterworks System

This change will add a \$10 fee to each water bill in Hayti to help offset the funds needed to refurbish the water tower. The cost to refurbish is \$190,500; approximately \$42k would need to be raised.

Weelborg and Biederstedt will schedule a working session with the Economic Development Board as well will invite the public, to discuss the gym and prospects for it and the water tower logo.

Weelborg made a motion to approve that Carol Reuer will attend a local finance officers meeting in Volga on Aug. 18, 2022; seconded by Struckman. All voted in favor, motion passed.
