The Board of Trustees, of the Town of Hayti, South Dakota, met on Wednesday, January 11, 6:30 p.m. at the City Office. Members present were Deb Goebel, Ron Schlenker, Greg Biederstedt, and Jeremy Struckman.

Others attending; Will Botha, Jason Koistinen, Dwight Kopman.

Chairwoman Deb Goebel called the meeting to order.

The Pledge of Allegiance was said.

Public Comment:

Schlenker made a motion to approve the agenda; seconded by Biederstedt. All voted in favor, the motion carried.

Minutes of the previous meeting of December 14, 2022 were read. Check #24683 was voided, Biederstedt made a motion to approve the minutes, Struckman seconded. All voted in favor, the motion passed.

Motion by Schlenker, seconded by Struckman, to approve the monthly financial report; all voted in favor, the motion carried.

newspaper of the Town of Hayti; Schlenker seconded the motion. All voted in favor, motion passed.

Struckman made a motion to approve the 2023 contract with Code Enforcement Specialists, Schlenker seconded the motion. All voted in favor, motion passed.

Regarding sidewalks; council members will look over a drafted ordinance and will have a first reading at next month's meeting. All residents with sidewalks in front of their property are required by ordinance to remove the snow within 48 hours after a snow accumulation. Letters will be sent to anyone who has not removed their snow.

A contract with the Hamlin County Sheriff's office was presented and discussed. The Sheriff's office will charge the city a minimum of \$370 a month. If they have any service hours for the town, that amount will be deducted; if the town does not utilize the full amount, the excess amount will be forfeited. Schlenker made a motion to approve the contract with the Hamlin County Sheriff's office, seconded by Biederstedt. All voted in favor, motion passed.

Todd Kays with First District will be meeting with council members over the next several months to update the Zoning Ordinance for the town. Council members decided to have separate working meetings with Todd/First District to accomplish this project.

Struckman made a motion to enter executive session for personnel reasons, at 7:05 p.m., seconded by Schlenker. All voted in favor, motion passed. Biederstedt made a motion to end executive session at 7:20 p.m., seconded by Struckman. All voted in favor, motion passed.

Schlenker made a motion to set the wages of employees for 2023, seconded by Struckman. All voted in favor, motion passed.
