A public hearing was held regarding Ord. 315, A Temporary Ordinance Regarding the Issuance of Local Medical Cannabis Establishment Permits and/or Licenses. No one came forward to discuss the Ordinance. The first reading was held for Ordinance 315. The second reading is scheduled for June 15, 6:00 p.m. at the city finance office.

Ron Schlenker will look over the changes that should/could be done regarding the pet ordinance. This was tabled.

The fireworks ordinance was discussed. Currently it allows residents to discharge fireworks on the 4th of July only. There were residents in favor of a longer period and residents who were in favor of the one day. Council members were in agreement that a longer period would be acceptable; a three day period would suffice. The steps will be taken to change the ordinance. It will not be in effect for this year; it is still legal only for the one day this year.

The code enforcement officer sent the current residences in violation of the cities ordinances.
