WHEREAS, the Town of Hayti has adopted Ordinance No. 218, Prescribing Rules, Regulations, and Fees Incident to Future Development of Residential Property; and WHEREAS, the Town Board desires to amend the current hookup fee to the sum of \$500.00.

NOW THEREFORE BE IT HEREBY RESOLVED that effective April 1, 2021, the hookup fee for new water and sewer connection shall be established as Five Hundred Dollars (\$500.00) On roll call, all voting "aye", Resolution declared PASSED and ADOPTED on the 10th day of March, 2021.
