The Board of Trustees, of the Town of Hayti, South Dakota, met on Wednesday, May 10, 6:30 p.m. at the City Office. Members present were Debra Goebel, Ron Schlenker, Greg Biederstedt, Matt Miller, Jeremy Struckman. Others attending: Dylan Reuer.

Chairwoman Deb Goebel called the meeting to order.

The Pledge of Allegiance was said.

Public Comment:

Biederstedt made a motion to approve the agenda; seconded by Miller. All voted in favor, the motion carried.

Minutes of the previous meeting of April 12 & April 25, 2023 were read. Struckman made a motion to approve the minutes, Miller seconded. All voted in favor, the motion passed.

Motion by Schlenker, seconded by Struckman, to approve the monthly financial report; all voted in favor, the motion carried.

Councilman Miller brought an ordinance that specifically deals with snow alert guidelines and the need to implement this policy/ordinance in Hayti. Carol will contact the city attorney to draw up an ordinance that will address the parking issues during a snow event. A first reading could be held next month.

Requests for a donation to the Hayti Swimming Lessons and Hayti Baseball/Softball group were accepted. Miller made a motion to give the swimming lessons organization \$1,500, to help off-set the cost for families; Struckman seconded the motion. All voted in favor, motion passed.

Struckman made a motion to donate \$500 to the Hayti Baseball/Softball group, Biederstedt seconded the motion. All voted in favor, motion passed. The baseball parents/coaches will be finishing the dugouts with concrete.

The Town of Hayti and Corwin were recognized by the DENR. One was a Drinking Water Certificate of Achievement Award and one for Operation and Maintenance Award; council members appreciate Corwin's hard work.

The next regular meeting is set for Wednesday, June 14, 2023; 6:30 p.m. at the City Finance Office.

There being no further business, motion by Miller; seconded by Reuer to adjourn. All voted in favor, the meeting adjourned.
