Public Comment:

Chairwoman Debra Goebel added Patty Uskoski to the agenda to talk about the ditches. Motion by Biederstedt; seconded by Schlenker, to approve the agenda. All voted in favor, the motion carried.

Ave. were received; John Hurley Excavation was \$3,500 and Basin Drain Tile was \$2,142.86.

Discussion on law enforcement was held with Patty Uskoski.

A variance request, by Kevin Schaefer for a variance of 2.05.05, section 3; the request, if granted, would permit the applicant to build a handicap ramp (structure) from the front deck to the sidewalk, which would not be within the 25' front yard setback. The handicap ramp would be built at 303 Pheasant Ave. in the Town of Hayti.

There was no discussion brought forward from residents; Biederstedt made a motion to approve the variance, D. Struckman seconded the motion. All voted in favor, motion passed.

Schlenker made a motion to approve the renewal of the liquor license for Renegade's, Biederstedt seconded the motion. All voted in favor; motion passed.

Schlenker made a motion to approve paying for Workman's Comp for the volunteer fire fighters, J. Struckman seconded the motion. All voted in favor, motion passed.

Patty Uskoski wants to know what the city is going to with the ditches on Charger Ave. in front of her house. The water does not run through and pools up in them, she wants them to be filled in. Discussion on how the water runs and where it would go if there wasn't a ditch was debated. Schlenker made a motion to hire Basin for the bid of \$2,142.86 to clean the ditch/culverts and reseed the right of way. D. Struckman seconded the motion. All voted in favor, motion passed.

The next regular meeting is set for Wed., Nov. 10, 2021; 6:30 p.m. at the City Finance Office.

There being no further business, motion by Biederstedt; seconded by J. Stuckman to adjourn. All voted in favor, the meeting adjourned.
