Chairwoman Deb Goebel called the meeting to order.

Doug Weelborg addressed the board; he wants to express that he thinks the things being said in the newspaper are opinion and disrespectful to the board. Doug thanked the council members, Corwin and Carol for doing a great job for the city. Ryan Keysar would like to see the cost of the license for Medical Cannibis be higher then what was first mentioned.

Motion by D. Struckman; seconded by Schlenker, to approve the agenda. All voted in favor, the motion carried.

## Police Report:

Corwin's Report: The ditch/culvert system on 4<sup>th</sup> St was looked at by one company, waiting on another company to get a second quote. Five spots in the street system will be blade patched yet this fall; working on fixing the east lift station.

Patty Uskoski wants to know what the city plans on doing with the ditches in front of her properties. She is not happy with the drain system and wants to fill in the ditches and culverts. She also wants to get rid of the city police department and contract with the Sheriff's office. Council members attempted to convey why the city has their own police department. Patty does not want to allow a medical cannabis dispensary in city limits; it was explained, that every city, by state law, has to allow at least one dispensary; the ordinances being put in place protects the city in making the laws and costs for zoning and licensing.

The Hamlin Homecoming committee requests a permit to discharge fireworks at the football field following the Homecoming football game on Sept. 17, 2021. Schlenker made a motion to approve the permit, J. Struckman seconded. All voted in favor, motion passed.

Insurance on the gym was tabled.

All voted in favor, motion passed. 2<sup>nd</sup> Reading of Ordinance 319 – An Ordinance Adding Chapter 6 to the Revised Ordinances of the City of Hayti Thereby Creating Licensing Provisions for Cannabis Establishments Within The City of Hayti, South Dakota.

The fee for licensing was discussed, D. Struckman made a motion to strike the \$5,000 fee with a \$2,500 refund for an initial license to read \$50,000 (fifty thousand) for an application fee with \$25,000 refundable if not approved by the state; and strike the \$5,000 renewal fee to read \$50,000 (fifty thousand) renewal fee; J. Struckman seconded the motion. All voted in favor, motion passed.
